Frequently asked questions

What are the fees to join Force Wrestling?

Fees for the 2008/2009 season are as follows:

\$175.00 (Registration fee / 1st wrestler)

\$140.00 (2nd sibling)

\$125.00 (3rd sibling)

\$140.00 (Tots (5-6), First year Bantam (7-8))

What does my fee include?

USAW Wrestling Card

Unlimited use of Training Facility

T-shirt, shorts and gym bag

End-of-year banquet and trophy

Are there any other obligations?

There is a mandatory raffle ticket fundraiser for each family. Each family must sell 10 tickets at \$10 per ticket.

This will be paid in full at registration.

Force hosts a tournament on December 14th and ALL parents are required to help.

Do I need to purchase a singlet?

Singlets are furnished by Force and need to be returned at the end of the season. There will be a refundable \$40 deposit required when picking up singlet.

What do I need to supply?

Each wrestler will need wrestling shoes and headgear which can be purchased at Dick Pond's or local sporting goods stores.

When does the season start and end?

Practices start in early November. There will be a mini-camp for all first year wrestlers to introduce them to the sport in late October. The season ends in late February or early March.

How many practices are there?

Tots and Bantams — 2 days per week

Midgets, Novice and Seniors — 3 to 4 days per week

What about tournaments?

Tournaments are generally held each Sunday (sometimes Saturdays) at high schools throughout the state. We choose tournaments based upon location and skill level. Tournaments are fundraisers for local clubs and cost the wrestler approximately \$15 to \$20. Attending tournaments is not mandatory but is highly recommended.

Can I volunteer to help?

Absolutely. There are numerous opportunities to help. See the board for ideas.

Can I help coach?

The success of our athletes and club is directly related to the coaching they receive. If you have coaching experience and would like to volunteer your time then please fill out the form at registration. See Head Coach Joe Arquilla for further information.

I, _____, the undersigned, on behalf of myself, my heirs and next of kin, personal representative, agents, insurers, successors and assigns (all hereinafter "Releasors") hereby **FOREVER RELEASE, DISCHARGE AND COVENANT NOT TO SUE THE UNITED STATES OF AMERICAN WRESTLING ASSOCIATION, INC., its insurers, its affiliated clubs, administrators, agents, directors, officers, state organizations, members, committees, volunteers, all employees of USA Wrestling, and any and all participants, officials, referees, coaches, host clubs, sponsoring agencies, sponsors, advertisers, local organizing committees (and if applicable) owners, lessors and operators of premises used to conduct any USA Wrestling sanctioned event, meet, practice or activity (all hereinafter "Releasees") from any and all liabilities, claims, demands, causes of action or losses of any kind or nature, past, present or future, direct or consequential that I may hereafter have for PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, arising out of my participation in, attendance at or traveling to and from any USA Wrestling sanctioned event or activity including, but not limited to, LOSSES CAUSED BY THE PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used.**

2. Releasor understands and acknowledges that USA Wrestling sanctioned activities and the sport of wrestling in general have inherent dangers that no amount of care, caution, training, instruction, supervision or expertise can eliminate. **RELEASOR EXPRESSLY AND VOLUNTARILY ASSUMES ALL RISK OF PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, sustained while participating in, attending, preparing for or traveling to and from any USA Wrestling sanctioned event, meet, practice or activity, including the risk of PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used.**

3. Releasor acknowledges and fully understands that each participant in any USA Wrestling sanctioned event, meet, practice or activity, including Releasor, will be engaging in activities that involve risk of serious injury, including permanent, temporary, total or partial disability, disfigurement, paralysis and any other losses to person or property, including death, and that severe social and economic losses may result not only from releasor's own action, inactions or negligence, but also from the actions, inactions or negligence of other notwithstanding the rules of play or the condition of the premises or of any equipment used. Further Releasor acknowledges and fully understands that there may be other associated risks with such activities which are not known or not reasonably foreseeable at this time.

Preamble:

Interscholastic and youth sports programs play an important role in promoting the physical, social and emotional development of children. It is therefore essential for parents, coaches and officials to encourage youth athletes to embrace the values of good sportsmanship. Moreover, adults involved in youth sports events should be models of good sportsmanship and should lead by example by demonstrating fairness, respect and self-control.

I and my child(ren) therefore pledge to be responsible for our words and actions while attending, coaching, officiating or participating in a youth sports event and we shall conform our behavior to the following code of conduct:

1. I and my child(ren) will not engage in unsportsmanlike conduct with any coach, parent, player, participant, official or any other attendee.
2. I and my child(ren) will not encourage any other person, to engage in unsportsmanlike conduct with any coach, parent, player, participant, official, or any other attendee.
3. I and my child(ren) will not engage in any behavior which would endanger the health, safety or well-being of any coach, parent, player, participant, official or any other attendee.
4. I and my child(ren) will not encourage any other person, to engage in any behavior which would endanger the health, safety or well-being of any coach, parent, player, participant, official or any other attendee.
5. I and my child(ren) will not use drugs or alcohol while at a youth sports event and will not attend, coach, officiate or participate in a youth sports event while under the influence of drugs or alcohol.
6. I and my child(ren) will not encourage any other person, to use drugs or alcohol at a youth sports event and will not permit my child, or encourage any other person, to attend, coach, officiate or participate in a youth sports event while under the influence of drugs or alcohol.
